

# Terms & Conditions

## CASH PRIZE DRAW

### Terms & Conditions

1. The promoter of this draw is Turloughmore GAA Club, the "Club", located at Social Centre, Lackagh, Co. Galway, Ireland. The purpose of the draw is to raise money to develop club facilities for the benefit of our members and local community.
2. Updates and news about the competition (the "draw") will be posted on our Club's social media channels and through our websites [www.turloughmoregaa.ie](http://www.turloughmoregaa.ie) and [www.turloughmore.com](http://www.turloughmore.com)
3. Turloughmore GAA has obtained a lottery license and a Raffle Licence from the District Court in Galway and An Garda Siochana.
4. No Ticket shall be sold to any person under the age of eighteen, but this shall not be deemed to prohibit the purchase of a Ticket for the purpose of making a gift by a person eighteen years of age or older to a person less than that age.
5. The cost of entry to the draw is € 20.00 for one ticket or € 50.00 for 3 tickets or €100 for 8.
6. Only those who have purchased an official ticket are eligible to participate in this draw.
7. Persons who buy a ticket on-line are issued with an electronic receipt. Their details will be transcribed onto a Spreadsheet along with the entrants of the paper ticket for inclusion in the computerised draw on the date of the draw.
8. By purchasing a ticket, an entrant is deemed to accept these terms and conditions.
9. These terms and conditions are governed by the laws of the Republic of Ireland.
10. There is no limit on the number of tickets that an individual may purchase for this draw.
11. Once purchased, no refunds will be issued except in the event of cancellation of the draw.
12. Any notice, announcement, information or bulletin in relation to the draw whether public or otherwise or wheresoever published is only intended to be a notice to the entrants of the draw and is not intended to be nor directed to any other persons whatsoever.
13. Turloughmore GAA Club's decision in respect of all matters to do with the draw will be final and no correspondence will be entered into in respect of the draw or the draw result.
14. The Club or its servants, agents, licensees, trustees, or executive committee members shall not be liable to the entrants for any loss, inconvenience, damage or expense suffered by the entrants participating in this draw.
15. The Club or its servants, agents, licensees, executive committee, trustees, or members

shall not be liable for any failure in the performance of its obligations due to factors beyond their control.

16. The prize is a cash prize. €25,000 payable within one month of the date the draw takes place by electronic transfer into a bank account nominated by the winner. The winner will be responsible for their own bank charges to receive the funds transfer.

17. Prizes are not transferable.

18. The winner of the cash prize will be responsible for all tax returns and any potential payments due to the Revenue Commissioners in respect of this income.

19. The organizers of this draw shall not derive any personal profit from it.

23. The winning ticket and ticket holder will be subject to verification by Turloughmore GAA Club. This process may take up to 14 working days to complete.

24. The winner will be notified by email, post, or telephone within three days of the draw date. Notification will also be posted on the Club's social media channels and in local media. The winner will be deemed to have been notified on the date of the email notification, telephone call or social media notice, or within three days of the date of any postal letter. If the winner cannot be contacted or does not claim the prize within 21 days of notification, Turloughmore GAA Club reserve the right to withdraw the prize from the winner and pick a replacement winner. In this event, any subsequent draw will take place in accordance with these terms and conditions until a new winner is established.

25. Turloughmore GAA Club shall not be liable for any failure in the performance of any of its obligations caused by factors outside its control.
